CALLING ALL RADIO AMATEURS, CALLING ALL RADIO AMATEURS. THIS IS <NCS CALL SIGN>, CALLING THE INDIANA SECTION A.R.E.S. NET.

THIS NET MEETS EVERY SUNDAY AT 5 P.M. EASTERN ON OR ABOUT 3900kHz. ITS PURPOSE IS TO DISCUSS TOPICS IMPORTANT TO OUR ABILITY TO SUPPORT PUBLIC SAFETY AND EMERGENCY COMMUNICATIONS THROUGHOUT INDIANA. ALL STATIONS WITH AN INTEREST IN PUBLIC SERVICE AND EMERGENCY COMMUNICATIONS ARE WELCOME TO PARTICIPATE. THIS IS A DIRECTED NET, SO PLEASE HOLD COMMENTS UNTIL RECOGNIZED BY NET CONTROL.

THE NET CONTROL STATION FOR THIS SESSION IS <NCS CALL SIGN + PHONETICS>. MY NAME IS <YOUR NAME> AND I AM LOCATED IN <YOUR COUNTY>.

WHEN CHECKING IN TO THIS NET, PLEASE STATE YOUR FULL F-C-C CALL SIGN USING PLAIN ENGLISH FOLLOWED BY STANDARD I\_T\_U PHONETICS, THEN YOUR NAME AND COUNTY. CHECK-INS WILL BE CALLED ACCORDING TO DISTRICT NUMBER ORDER.

AT THIS TIME, I'LL STANDBY FOR ANY STATIONS WITH EMERGENCY OR PRIORITY TRAFFIC? PLEASE CALL NOW.
